**PROVISIONAL ADMISSION NOTICE FOR FIRST YEAR**  
**B.A., LL.B.(HONS. )(SEMESTER – I) FOR THE SESSION 2026-2027**

As per the direction of Council for Under Graduate Studies, University of North of Bengal vide Ref. No.: 148/UG-26 dated 15.05.2026 it is notified that the provisionally selected candidates for the provisional admission in First year of B.A., LL.B.(Hons.)(Classes - 1<sup>st</sup> Semester) of 5 year integrated Law Course for the session 2026-2027 should deposit through online mode through, our college website i.e. [www.jalpaigurilawcollege.in](http://www.jalpaigurilawcollege.in) of Rs.14,450/- (Rupees fourteen thousand four hundred fifty only)(including University Registration Fee Rs.300/-) for B.A.,LL.B.(Hons.) Course.

*After depositing the amount online, the candidate has to send a scan copy of the online deposited/transaction receipt to our college email id: [jallawcollege@rediffmail.com](mailto:jallawcollege@rediffmail.com) on the date of deposit.*

The candidates who have taken admission are advised to bring all necessary original documents such as Madhyamik / ICSE / CBSE i.e. class 10<sup>th</sup> Admit Card as age proof certificate, Mark Sheet of Higher Secondary (10+2) or equivalent examination, S.C./S.T./O.B.C./P.H./E.W.S. (if applicable) certificates in the name of the Candidate etc. and E.W.S. Certificate in the name of Candidate is valid for the current financial year of issuance of certificate by the Competent Authority in Government of West Bengal. Along with 2 sets of attested photocopies both side of all documents and 2 passport size recent coloured photographs during office hours for verification on the date of Commencement of Classes (As per the order of Government of West Bengal and University of North Bengal time to time.) and after verification if the College Office is satisfied in all points the candidate will be treated a **“Provisionally Admitted Student”** otherwise his or her **admission will be treated as cancelled.**

*If the certificate produced by the candidate at the time of verification is challenged by any person/authority, the validity or the authentication will be done by the appropriate issuing authority or the final decision of the appropriate Court of Law.*

The Roll No of Admitted Candidates will be given/posted by the College on the date of Commencement of Classes after proper verification of documents with originals.

*The provisionally selected candidate according to approved merit list should take provisional admission within the stipulated period mentioned below in the schedule of provisional admission otherwise the claim for provisional admission will be forfeited.*


**SCHEDULE OF PROVISIONAL ADMISSION OF 2<sup>ND</sup> MERIT LIST.**

2. Candidates other than West Bengal Board should submit Original Migration Certificate for the Purpose of University Registration at the time of verification of all documents.

Candidates who have already admitted in other institution and having registration number of the University must produce original registration certificate along with the release certificate from the College Authority where he/she has studied last, at the time of verification of all documents and no further date will be given for the same. 
4. **DRESS CODE:** Students shall wear formal dress of legal profession in pupilage as follows:  
*i. FOR MALE STUDENTS:* White/ Black Trouser/, white shirt/, black tie, black coat, black socks black leather covered shoe. *ii. FOR FEMALE STUDENTS:* White/Black Trouser/Salwar, white shirt/Kurta, black tie/Dupatta, black coat, black socks, black leather covered shoe.  
*iii. OPTIONAL FOR GIRL STUDENTS:* Black printed sari, white full sleeved blouse, black leather covered shoe.
5. **ATTENDANCE:** No student shall be allowed to take the end semester written examination if the student concerned has not attended minimum of 75% of the classes held in the subject concerned and also in other curricular components.
6. **The Classes will commence from 4<sup>th</sup> July, 2026 at 11.00 A.M.**
7. Anti-Ragging Undertaking must be filled by the students online on <http://www.antiragging.in> only. Universities/Colleges will not accept Anti Ragging Undertaking by students in Hard/Printed copy/Affidavits.
8. **Parents and Teachers meeting will be held on 4<sup>th</sup> July, 2026 at 1 P.M. at the college premises.**

#### MANNERS AND DISCIPLINE

- I. The college expects from its students – a disciplined and dignified manner within and outside the college premises.
