PROVISIONAL ADMISSION NOTICE FOR FIRST YEAR

MASTER OF LAWS(LL.M.) (SEMESTER – I) FOR THE SESSION 2026-27

It is notified that the provisionally selected candidates for the provisional admission in First year of Master of Laws(LL.M.) (1st Semester) classes of 2 year Course for the session 2026-27 should deposit through online mode through, our college website i.e. www.jalpaigurilawcollege.in of Rs.12, 575/- (Rupees twelve thousand five hundred seventy five only)(excluding University Registration Fees, if any).

After depositing the amount online, the candidate has to send a scan copy of the online deposited/transaction receipt to our college email id: jallawcollege@rediffmail.com on the date of deposit.

The candidates who have taken admission are advised to bring all necessary original documents such as Madhyamik / ICSE / CBSE i.e. class 10th Admit Card as age proof certificate, Mark Sheet of LL.B. examination, S.C./S.T./OBC/PH/EWS (if applicable) certificates in the name of the Candidate etc. along with 2 sets of attested photocopies both side of all documents and 2 passport size recent photographs during office hours for verification on the date of Commencement of Classes (As per the order of Government of West Bengal and University of North Bengal time to time.) and after verification if the College Office is satisfied in all points the candidate will be treated a **"Provisionally Admitted Student"** otherwise his or her admission will be treated as cancelled. The Roll No of Admitted Candidates will be given/posted by the College on the date of Commencement of Classes after proper verification of documents with originals.

If the certificate produced by the candidate at the time of verification is challenged by any person/authority, the validity or the authentication will be done by the appropriate issuing authority or the final decision of the appropriate Court of Law.

The provisionally selected candidate according to approved merit list should take provisional admission within the stipulated period mentioned below in the schedule of provisional admission otherwise the claim for provisional admission will be forfeited.

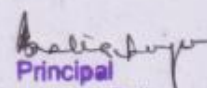
SCHEDULE OF PROVISIONAL ADMISSION OF 7TH MERIT LIST.

Note: 1. Further merit list will be published on the basis of the seat vacant. The candidates are advised to follow the college website for regular interval.

2. Candidates other than University of North Bengal should submit Original Migration Certificate for the Purpose of University Registration at the time of verification of all documents.

3. Selected candidates are required to submit a Declaration stating that he or she is not engaged or will not be engaged in practice in a court during the regular LL.M. Course to ensure 75% attendance as per the University norms. Moreover, the candidates are advised to send a mail to our college mail id: jallawcollege@rediffmail.com if he/she is taken admission in other institution after taking admission in Jalpaiguri Law College.

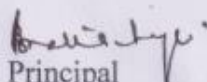

MANNERS AND DISCIPLINE

- I. The college expects from its students – a disciplined and dignified manner within and outside the college premises.

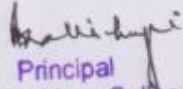
