B.A., LL.B.(HONS.)(SEMESTER – I) FOR THE SESSION 2023-24

As per the direction of Council for Under Graduate Studies, University of North of Bengal vide Ref. No.: 85/UG-23 dated 26.05.2023 it is notified that the provisionally selected candidates for the provisional admission in First year of B.A., LL.B.(Hons.)(1st Semester) classes of 5 year integrated Law Course for the session 2023-2024 should deposit through online mode through, our college website i.e. www.jalpaigurilawcollege.in of Rs.15,350/- (Rupees fifteen thousand three hundred fifty only)(including University Registration Fee Rs.200/-) for B.A.,LL.B.(Hons.) Course.

After depositing the amount online, the candidate has to send a scan copy of the online deposited/transaction receipt to our college email id: jallawcollege@rediffmail.com on the date of deposit.

The candidates who have taken admission are advised to bring all necessary original documents such as Madhyamik / ICSE / CBSE i.e. class 10th Admit Card as age proof certificate, Mark Sheet of Higher Secondary (10+2) or equivalent examination, S.C./S.T./ OBC- A /OBC- B/PH/E.W.S. (if applicable) certificates in the name of the Candidate etc. and E.W.S. Certificate in the name of Candidate is valid for the financial year of issuance of certificate by Competent Authority in Government of West Bengal. Along with 2 sets of attested photocopies both side of all documents and 2 passport size recent photographs during office hours for verification on the date of Commencement of Classes (As per the order of Government of West Bengal and University of North Bengal time to time.) and after verification if the College Office is satisfied in all points the candidate will be treated a "Provisionally Admitted Student" otherwise his or her admission will be treated as cancelled. The Roll No of Admitted Candidates will be given/posted by the College on the date of Commencement of Classes after proper verification of documents with originals.

The provisionally selected candidate according to approved merit list should take provisional admission within the stipulated period mentioned below in the schedule of provisional admission otherwise the claim for provisional admission will be forfeited.


1. DATE OF STARTING OF PROVISIONAL ADMISSION: 13/06/2023


